- 1. Call to order: (5:47 pm)
- 2. Review Task Force Agreements
- 3. Public Comment: (5:50 pm)

- 4. Approval of minutes (5:51 pm)

- 5. Restate charter deliverables
 - Tri chairs reviewed the charge of the Task Force as well as the language from the
 district website regarding the purview of the Task Force. It was noted that the Task
 Force is being asked to not only look for budget reductions but to also identify areas
 of priority need where the district might consider reallocating in combination with
 reductions in order to better support the district's stated strategic goals.

Questions:

- Why are we reviewing this?
 - It is important that we are in agreement on what it is and is not that the Task
 Force is being charged with. We want to make sure we all have our sights on the

- same end goal so that we are better able to arrive there in the agreed upon timeframe.
- Why are we being given a list of recommendations from the district? I thought the idea was for Task Force members to come up with their own recommendations.
 - The tri-chairs have requested that the district provide a list of options as a starting point. Given that the district has been facing a deficit for some time now, we want to understand the options the district has either considered or could consider. The list is not intended to limit the options we explore and members are encouraged to think beyond the options the district provides.
- When can we start offering our personal recommendations?
 - Anytime, recommendations can help inspire discussions and ideas within the committee.
- Is the committee moving forward with subcommittees?
 - That will be more organic. If there is interest in one specific topic a recommendation for subcommittee work can be made. (A little over half of members present indicated they would be interested in serving on a subcommittee)
- Why would we analyze AROI if we are not going to be able to include that in our recommendation?
 - The district is contracting with DMGroup who is helping the district standardize how it evaluates the relative effectiveness of its programs and initiatives. The Task Force can recommend that the district continue to deepen that work or it can suggest a different approach but to get to the level of moving forward with cutting a program or initiative, there would need to be a lot more internal vetting and feedback from those involved.

6. Revisit Criteria and Guiding Principles –Tri-Chairs Questions:

- What is the rubric for the criteria? We need to all be in agreement about what constitutes a high or low level of impact on any given criteria.
 - Yes and no. We will likely have to provide a dollar range for rating financial impact, however for other criteria, it there is really no way to accurately quantify and we will have to rely on people's informed opinions and perspectives. The criteria is intended as a tool to help us think, not to be an exact science.
- Can there also be a general "Are you for this idea?"
 - Yes, at the end of the day, it will likely come down to the fact that we evaluated each option on the basis of the five or more criteria, but ultimately it will be something like on a scale of 1-10, I support each option.

7. Clarify Scope

 Nicole Conley Johnson presents on the district's strategic plan and how the BSTF is being asked to act as one of the many inputs district leadership will look to in making its recommendations to the board. BSTF members are not expected to be experts but to offer perspective drawing from their own expertise and vantage point and speaking on behalf of the stakeholder groups they represent.

Questions:

- Do we know what the state will do if we become an outlier? If we fall below the mark?
 - We have an idea, it's happened to other districts and even to AISD in the
 past. We can be confident that the way the state would run things would not
 be in alignment with our values and we cannot afford to let them come in
 and make decisions for us.
