 - a. Melissa Acosta: Ridgetop Parent Strongly supports dual language programs Urges task force to keep funding in dual language and increase stipend for teachers teaching in dual language classrooms.
 - b. Jenna Stephenson: Ridgetop Parent Strongly supports dual language programs (dual language can help attract and retain students). Stayed in AISD because of dual language. Urges the district to increase stipend for teachers teaching in dual language classrooms.
 - c. Beth Knapp: Ridgetop parent Strongly supports dual-language programs. Dual language should be considered a fundamental strategy for staying competitive in the area
 - d. Clara Bradberry: Ridgetop Parent Decided to stay at Ridgetop because of the dual language program. Asks that the committee maintain funding for dual language and increase stipends for teachers teaching in dual language.
