PROCEEDINGS

Preliminaries

- The virtual meeting via Zoom was called to order by Dr. Jane Ross at 4:01 p.m.
- There were no public comments.

Superintendent's Update

- Dr. Elizalde provided an update that included the following points:
 - Her upbringing, education, and work background.
 - Her educational philosophy, including: every student and every school; district culture and climate; social and emotional learning; keeping an open mind; student outcomes; and seeking first to understand rather than to be understood.
- Questions and comments included:
 - Students have high potential, but we have had low expectations.
 - Every student deserves a good school and a good experience.
 - With virtual meetings, maybe we can get more diversity among all our committees diversity makes us strong.
 - Kids are getting on buses without having their temperatures checked.
 - We need to know more about which schools are being closed due to COVID.
 - [Superintendent] Health and safety are at the forefront of our decision-making. We have now been upgraded from Stage 4 to Stage 3; from September 8 to October 2, we will be virtual-only

with students, so no bus routes will be running during this period; keeping up our vigilance as a community is the key to opening up.

- What are the parameters for closing and reopening campuses?
- [Superintendent] There are varying recommendations from different agencies, so we have to decide on what parameters to use.
- The clarity with the Board at their last meeting was appreciated.
- [Superintendent] When we do open, we want to stay open going back and forth is not good.
- Board meetings often go on very late, which is not conducive for many in the community to watch or participate.
- [Superintendent] This is a Board operational issue, but I myself will become more prepared, which will help move things along.
- There are health and safety concerns related to schools serving as polling places.
- [Superintendent] We will definitely work on this.

Reopening Plan Updates

- Erin Bown-Anderson provided an update that included the following points:
 - What the first three weeks of virtual school will look like.
 - We are now guests in the homes of our students.
 - Equitable access.
 - Scaffolding, learning modules, and professional development courses for teachers.
 - Devices being provided to students who need them.
- Lisa Bush and Monica Gonzalez provided an update that included the following points:
 - Guiding principles and priorities, including health and safety, equitable instruction, and building relationships.
 - Revised 2020-2021 academic calendar.
 - Even with all strategies in place, it will be impossible to totally remove the risk of COVID in schools.
 - © Communication and engagement activities, including a dedicated website updated daily.
- Alexandra Copeland and Matias Segura provided an update that included the following points:
 - Health screenings of students, staff, and visitors.
 - Social distancing measures, face coverings, frequent hand washing, cleaning protocols, contact tracing, and student-friendly posters.
 - Following CDC protocols.
 - Operations checklist, including transportation, food services, furnishings, and outdoor learning.
 - AISD is doing good at this time in terms of available PPE.
 - Building refits, including air filters, water bottle filling stations, and plexiglass installation.
 - Detailed individual facility plans=, which will be audited for implementation.
- Kevin Schwartz provided an update that included the following points:
 - All our supplies for student devices have been secured.
 - We are meeting demands for providing hot spots.
 - We are prioritizing service to hard to reach students.
- Questions and comments included:
 - © Concerned over attention give to athletics over academics, and what are we doing with teachers' kids?
 - [Medina] We are encouraging staff with children to work from home.
 - Are all staff given the option to work remotely starting September 8 if they don't feel safe?
 - [Medina] We are ensuring social distancing and proper PPE. Based on a recent survey, most teachers are willing to come back, with certain conditions. We are working with principals to determine the exact numbers of staff working remotely to make sure we're prepared.

- How are we making sure teachers are getting all the information they need it shouldn't be left up to individual campus leaders.
- [Medina] We will commit to work as senior staff to ensure good communications.
- How do we rigorously enforce everyone wearing face coverings?
- Gonzalez] It really will be a community effort educating the critical importance and making part of our culture. We don't intend at this point to make it a disciplinary issue.
