PROCEEDINGS

Preliminaries

- Following a tour of the new Menchaca Elementary School campus, the meeting was called to order by Dr. Jane Ross at 5:02 in the school library.
- There were no public comments or comments from members.

2020 Census Update

- Joey Crumley provided an update on the 2020 Census, which included the following points:
 - ☞ AISD Census website serves as a one-stop shop for Census information
 - ☞ AISD is participating in the local Complete Count Committee
 - ☞ The Census Bureau website includes a Statistics in Schools tools for classroom teachers
 - ☞ AISD has received a \$45,000 grant from United Way to support campus-based Census promotions
 - ☞ People will start receiving postcards in the mail in March instructing them to complete the Census form
 - ☞ This will be the first time the Decennial Census may be completed online
- Discussion points included:
 - ☞ Confidentiality of Census data
 - ☞ Populations at risk of being undercounted
 - ☞ Legal limitations on how people can help others complete Census forms
 - ☞ Assistance is available in other languages, and for the blind and deaf
 - ☞ Census Bureau representatives are available and eager to come to campuses to speak and provide information at events

District Performance Report

- Carolyn Hanschen, Director of Campus and District Accountability, provided a summary of annual district performance that included the following points:
 - ☞ District and campus letter-grade ratings
 - ☞ Campuses receiving distinction designations
 - ☞ Student demographics
 - ☞ Student enrollment by program
 - ☞ STAAR/EOC performance by subject and student group
 - ☞ Attendance and graduation rates by student group
 - ☞ Violent and criminal offenses
 - ☞ Student postsecondary performance
- Discussion points included:
 - ☞ We shouldn't be happy with just meeting state standards – it's not good enough.

- ☞ There are some schools doing well with large economically disadvantaged percentages, but they're doing things other schools don't want to do
- ☞ When kids aren't having fun at school, they stop learning – we need to find ways to stimulate their interest.

District of Innovation Plan Amendment

- Mr. Crumley went over proposed amendments to the AISD District of Innovation (DOI) plan that would allow for non-certified academic language therapists, due to a shortage in the certified staff (CALTs). He pointed out that the DAC previously supported such a provision for CTE instructors in the original plan.
- Mr. Crumley also pointed out that state law requires a formal vote of the DAC on any DOI amendments – if the DAC does not support the amendments, they cannot proceed to the Board.
- Norma Castillo, Director of Talent Acquisition and Development, was unable to make the meeting, but phoned in for the discussion.
- Several DAC members expressed concerns over the proposed amendments, and many members wanted to see more information.
- This item was carried over to the next DAC meeting.
