- Goal 2022-2023 is to adopt a balanced budget

- 18% increase in property taxes so our recapture to the state will increase
- Teachers will still get a 3.7% pay increase.

- Focus on core courses / SEL / PE
- Certified teachers along with multiple support staff in the areas of counseling
- A primary focus is on appropriate decision making skills
- Invest / Positive Families is offered to all students to ensure that students make better choices
- Grant allowed them to offer a reading program to all ALC students
