PROCEEDINGS

Preliminaries

• The virtual meeting via Zoom was called to order by Dr. Jane Ross at 4:30 p.m.

- As this was not a regular meeting, there was no time allotted for public comments.
- Dr. Ross introduced the presenters and acknowledged Trustees in attendance.

Proposed Waiver and Asynchronous Plan

- Dr. Reach and Mr. Hicks went over the following points:
 - The TEA waiver, which was authorized by the Board, requests to extend the school year transition beyond four weeks.
 - The waiver requests a phased-in approach, with up to 25% on-campus attendance during the first two weeks of the extension, and up to 50% on-campus attendance during the third and fourth weeks of the extension.
 - The Asynchronous Plan provides the district flexibility to earn daily attendance through highquality instructional practices with daily engagement measures. The plan includes both synchronous and asynchronous learning, with blended instructional minutes.
 - The plan also includes opportunities for related teacher professional development.
- Also present for questions and comments were Dr. Elizalde, Lisa Bush, and Monica Gonzalez. Questions and comments included:
 - Question: In the future, will be looking at any type of hybrid model?
 - Answer: It's important that we do have a plan for various scenarios.
 - Comment: I heard that there may have been some changes to the original reopening plan?
 - Response: After talking to principals, it's best to stick with the original plan. We will continue to have a lot of conversations.
 - Question: Around the holidays, we will have more testing?
 - Answer: We are not currently testing on-site, but we will definitely monitor closely after people come back from the holidays, and we'll continue to monitor of facility safety plans.
 - Question: Do all staff have to report back on October 5 unless they have an approved accommodation?
 - Answer: We still have to look at accommodation requests and then decide how to proceed.
 - Comment: We need more transparency about shut-down triggers.
 - Response: We're using even stricter protocols than those recommended by health officials.
 - Question: How have we been listening to voices of people who have no option but going back to campus?
 - Answer: We did offer a survey to all parents, and we can see the results by individual campus. Very few people have supported returning as if nothing ever happened.
 - Comment: We can't expect teachers and parents to constantly remind kids to keep their masks on – we have to take care of our teachers' health.
 - Comment: More teaching assistants are taking on the responsibilities of regular teachers who are out with accommodations.
 - Response: The survey is still going on, but will soon close, and then we'll be able to assess the situation better.
 - Question: What happens when students exhibit symptoms?
 - Answer: Any students showing symptoms will be escorted to an isolation area. All safety protocols will be followed, including contact tracing. All staff are being trained on safety protocols.
 - Question: Are any problems being encountered with devices and at-home learning?
 - Answer: There were a lot of technical assistance calls the first week, but they are decreasing greatly.
 - Question: Is there actually a nurse physically on every campus?
 - Answer: Not at every campus. Some are on-site at certain times.
 - Comment: There are a lot of people who are afraid, and we need more transparency about what teachers are really saying.

- Response: We are definitely listening to teachers and to all stakeholders we understand their concerns.
- Question: Are teachers getting ample technical support?
- Answer: We do need to plan around how many kids can manageably be in a virtual classroom; we are looking at more teacher professional development in this regard.
- Question: Are staff being tested prior to returning?
- Answer: Currently, we don't have the capacity, but we are still looking into it.
- Question: Are athletes being tested before returning to practice?
- Answer: There is no requirement for this.
- Comment: Many teachers are very scared to return, as well as their kids.
- Question: Why aren't athletes being tested?
- Answer: We were told by local health officials that it isn't necessary. They are required to wear masks when not physically participating in their sports.
- Comment: Perhaps athletic trainers could help monitor the athletes for any symptoms.
